Following are the rules for the Trial Panorama Print Contest to be judged at Springbrook. Entrants will need to have their images delivered to Springbrook - there is no mailing address for this contest. Better yet, join us for Springbrook and be there to see all the entires!

#### Panorama Print Rules

- 1. This contest will be considered to be in the large print category. Current Large print rules will be followed with the following changes;
- 2. A Panorama print is considered to consist of two or more exposures stitched together to form a single print.
- 3. Open contest, any subject, mode or process, color or Black & White.
- 4. The print may be produced by the entrant or by a commercial laboratory.
- 5. Prints may be of any size or shape not to exceed 320 square inches.

The print MUST be mounted with the size of the mount not to exceed 320 square inches.

- 8. Any contingency not covered by these specific Rules for Large Print Nature Prints or the Procedures & General Rules will be referred to the Chair of the N4C Black & White Pictorial and Nature Prints Competition whose interpretation and decision will be final.
- 9. Ribbons will be awarded according to current N4C judging club rules. -George Bebout, Parlimentarian



### The N4C Photo Essay Contest

A picture is worth a thousand words—but what if <u>your</u> picture(s) are asking for some music and words to complete the story! The N4C photo essay is your chance to combine your photography, your choice of music, and if you wish narration to tell your friends about your favorite place for photography, illustrate a 'how to', or just to have fun. The subject matter is completely open, you can mix and match the old and new, and use as much creativity and imagination as you can find (or borrow from those who have done this before!). **Note that the maximum length is 6 minutes.** 

Now's the time to consider what your story will be and start getting your slides and negatives scanned, or digital images together or to take that extra image or two that will round out what you need. You'll also need to find the music and compose any narration you wish to use for your essay. Pro Show Gold or Producer (Photodex) are favorite of PC users while those Mac's favor iMovie 06, iMovie 08 or Final Cut Pro Express. Here's the best guidance for producing an essay: use any software you want to put your essay together, but make sure that it can be exported to DVD format. The end result should play on all computers and on your home DVD player. (Note that those who have the new PC Vista operating software will need to burn DVD's with the 'mastered' format selected before burning to insure compatibility with computers running older PC software or MAC software.). If you have any questions about software, conversion to DVD format or other topics, please don't hesitate to contact me directly at <a href="mailto:d.tomes@mac.com">d.tomes@mac.com</a> or call me at 515 986 3913.

Here's what you need to know about the judging. The three areas that are judged are (1) overall impression, (2) photography and (3) commentary and sound track. The overall impression includes interest, originality, mood and impact while the photography stresses the familiar categories of technical quality, composition, variety, and absence of distractions. The commentary and sound track are judged on their style, appropriateness, and combination of music, narration, and sound effects. One additional factor for the slide essay is how all the components flow together to tell the story—visually, sound, and 'smoothness'.



#### Letter to the editor:

We now have passed the half way point of the 2008-09 contest year and there are clubs still not following the judging rules. Clubs are still not giving comments on the images. If we don't give constructive comments on images, how will we grow and evolve into better photographers? I'm sure the judging clubs will say "It is too time consuming", so I'll help you shorten this time. Give <a href="maybe">maybe</a> (not necessary) one good comment, but leave out the lame "nice sky" – "good color" – "sharp" type comments. You learn more from what is wrong not what is right! If you have a thin skin, don't enter contests! Critique the <a href="maybe">actual</a> image you are judging, not the way you'd like to see it in a perfect world. There are usually extenuating circumstances that dictate the way the image was made i.e. clutter, limit of accessibility, etc., or maybe the photographer just liked it this way. Judge it as it is.

What is the point of the scoring system? At our club's last N4C judging, we scored by the point system, then took the top six prints and laid them side by side. By doing this, we then picked the final order of finish. The one that scored higher by points clearly was not the best. It wound up number three. When you are judging the c/c category you need to open your mind! After all, it is creative! Just because you don't know exactly what the image is, you shouldn't score it low. You should actually score it higher for it's creative endeavor.

Hopefully this year in our in our end of year awards, we will not see any computer generated slides in any of the slide categories. There is no such thing as glowing edges, etc. built into slide film. Anything computer aided, generated, or created belongs in the DIGITAL categories. Not in the slide categories. Please show some integrity and not enter these things in the categories made for slide film.
