

## President's Message:

Things have moved breath-takingly fast over the last two weeks! Chances are, more changes will have occurred between the time of writing this message and its publication.

As you no doubt know, we have had to make several significant changes to upcoming N4C events. The Spring Mini-Convention is cancelled; print contests for April and May have been cancelled; and the Panorama Contest has been cancelled. As with other organizations, N4C's actions have two purposes. First, we need to protect the health and well-being of our members, many of whom are in groups most vulnerable to the coronavirus. Second, it is through our



collective action that we can limit the spread and lessen the severity of the disease.

We will, however, plan to continue with digital competitions scheduled for April and May, which can be judged without needing to convene. In another article in this Newsletter, Diane Darnielle and John Larson provide advice on how digital contests can be judged by distance.

The rapid changes we have seen have disrupted our usual routines and limited our social contacts. These changes put a premium on finding new ways to stay active and involved. In the spirit of fostering activity and



social connection, I report that my local club tried holding its Monday, March 16 meeting remotely, with the use of Zoom software. Each participating member interacted from their home or laptop computer. It worked surprisingly well, with members able to share images full screen and to exchange comments and ideas freely.

It is to be hoped that our photography hobbies will continue to provide us with opportunities to stay active and engaged in this challenging time. Please let me know if you and your club members have other ideas on how to share their photography interests while maintaining social distance. 


## N4C SPRING MINI-CONVENTION 2020 April 24, 25 & 26, 2020 Wesley Woods Camp & Retreat Center.

The N4C Board has voted to join many other organizations in being proactive in slowing down the spread of the novel coronavirus: We have decided to cancel the Spring Mini-Convention scheduled for April 24-26, 2020. The decision is based on our concern for the health and well-being of our members and our understanding that social distancing (including avoiding large gatherings) is an important social tool for slowing the spread and limiting the severity of the disease in our communities.

## N4C PRINT JUDGING CANCELED FOR APRIL AND MAY

Following our recent decision to cancel the Spring Mini-Convention, the Board has also voted to cancel the Print competitions for April and May. The Panorama competition, a print competition normally held at the Spring Mini-Convention, is included in those decisions, and so will not be held this year.

At this time, we intend to continue to hold the digital competitions for the rest of the year. Given the sudden and disruptive drop in social connections in all aspects of our lives, it is important that we do whatever we can to keep ourselves active and connected. It is possible to hold digital competitions without requiring judges to gather. Although some might find this less than ideal, others report that having judges review and evaluate images from their home computers has its advantages. Several of our members have already spoken up and offered advice on how to conduct judging from home computers.

#### General Comment from Ken Johnson:

Not being able to meet together for judging digital competitions necessitates some changes. Though print competitions have been canceled, N4C plans to maintain the digital competitions. I am pleasantly surprised that most clubs scheduled to judge in April & May have managed to find a method of their own. Some already use DropBox, SmugMug, Zoom, and other photo sharing and conferencing applications. Nine out of the twelve clubs judging in April & May have their method of judging. I am pretty sure the other three will be okay when I hear from them.

Many Camera Clubs are now judging photo competitions on-line, from home on their own monitors. Regardless of the method, a means for judges to communicate scores and comments to the Judging Chair is needed. I have tried to make that easier.

An Alternate Version of the N4C Judging Software has been sent to the April & May judging clubs. Briefly, there are new simplified spreadsheets for each judge to use for scoring and making comments – no macros – just the basics. When the Judging Chair receives the Judges' spreadsheets, compiling the scoring by 'copy and paste' onto the new alternate ENTRIES spreadsheet has been simplified.

When it comes to supporting the N4C member clubs, I am sensitive to ease of use and cost. Larger clubs and those with members having Zoom & SmugMug licenses can take advantage of applications with more features.

Many methods of judging are being shared in this issue of the N4C News Bulletin. I hope you will discover ways to improve and streamline judging within your club.

I congratulate all of you who have worked out methods for judges to view competition entries from home and keep our N4C digital competitions active. The March results show that interest and entry numbers are running high. Thank you for judging. It is wonderful we can stay active in this way, when you realize all the other events that have had to be canceled as a result of the pandemic.

## **DMCC Process for Judging Digital N4C Contests**

#### By Diane Darnielle

#### Method of Digital Judging by Judges at Their Homes

**Used by the Des Moines Camera Club** 

Documented by Ken Johnson 3/20/2020

This paper is to describe a method for judging N4C Competitions as well as camera club contests without requiring judges to physically meet together. This is one method used by the Des Moines Camera Club for many years. It has stood the test of time for club digital contests and their N4C judgings.

#### Briefly, the method provides

- A judging system for the contest chair
- A method of uploading the contest entries to a secure web site to be viewed by each judge
- A web link for the judges to view & scroll through the entries while they score & make comments.
- A spreadsheet for each judge to record scores and make comments
- Judges are allowed a window of several days in which to independently judge the entries.
- A spreadsheet from each judge to be returned to the contest chair.
- The contest chair combines the scores & comments onto a master spreadsheet
- The contest chair sorts the scores, emails judges to break ties, and sets the awards.
- The rest of the process to communicate the results is the same as we have always done.

The method uses a photo sharing web service named "SmugMug" for sharing and viewing entries.

SmugMug is described as a photo-sharing service popular among professional photographers. The software allows you to upload proofs and final edits into a gallery that you can then send to your clients so they can order prints.

If we agree to standardize on this method, if there is sufficient need, I envision that N4C could cover the cost of the service similar to the way the Des Moines Club has. DMCC uses the "Power" level of subscription which allows for unlimited photo uploads: <a href="https://www.smugmug.com/plans/power">https://www.smugmug.com/plans/power</a>. A pretty good investment for \$72/yr. But DMCC is a large club. Many clubs have their own members who personally use SmugMug and other photo sharing capabilities adaptable for club use.

In the pages that follow is an example using the March 2020 N4C Digital Altered Reality contest being judged by the Des Moines Camera Club. Diane Darnielle is the contest chair for this month's contest. The judge's names are fictitious.

Diane has received the entries from each of the camera clubs and saved them in a folder on her computer until after the submission deadline - just like normal.

#### The EXAMPLE:

In advance of the contest, Robert (the club SmugMug technical person) sets up the SmugMug web site to receive the entries for Diane.

Here you go, Diane. (Copies of the computer screens of these links on the next pages)

**Upload link:** (Here would be the web link to click for Diane to Upload the entry jpg files. It is a link to the Des Moines club SmugMug where she could just drag the image files from her computer folder and drop them on this web page where they would be uploaded and made available to the judges in the "Judges Link." The judges do NOT use this link – just used by the contest chair to upload the entries).


**Judges link:** (Here would be the web link for each of the judges to view all the entries on their home computer. No training on this should be needed)

Diane now uploads all the contest entries to the SmugMug web. Either drag and drop onto this screen or Browse to find and select.

After the entries are uploaded, the judges are notified and the judging can begin. In this example the judges are given a window of 5 days in which to complete their individual scoring and comments.



The order of the images in the SmugMug screen/folder uses the same file ordering as the spreadsheet uses when it is sorted by filename.

When the three judges email their completed spreadsheets to Diane, she adds their name to the file-name, so each spreadsheet has a different name. She then copies and pastes the three judges' scores and comments to a master spreadsheet. After she totals the scores and sorts them, she sends an email back out to the judges to break any ties if necessary.

The rest of the process to communicate the results to the entering clubs is the same as we have always done.

#### **Judging N4C Digital Contests Using Online Meeting Software**

(Written specifically to use Zoom on a Windows PC, but could easily be modified to use others like Skype etc. on MacIntosh hardware). This process allows all the judges to see the images at the same time and converse among themselves or with the chairpersons when questions arise regarding the images, rules or procedural questions.

#### 1. INITIAL SETUP

The judging chairperson will need to load all the images and Ken Johnson's spreadsheet (ENTRIES.XLS) into a folder on their PC. All computers used will need to have a video camera, most since 2010 have them. All the

judges should have calibrated monitors or HDTV and sufficient (bandwidth) Internet connection. Only the judging chairperson will need a Zoom account (free up to 40 minute meetings). I have a full account as part of my college teaching. If the 40 minutes is not enough time all one has to do is close that meeting and start another one.

- 2. SIGNING ON TO ONLINE MEETING The judging chairperson signs on to Zoom and selects "Host an Online Meeting" with Video On. Once the meeting has started the judging chairperson selects "Invite Participants" which will send a link to the meeting to all the persons when the chairperson supplies the judge's e-mail address. Once all the judges have joined the meeting, the chairperson will go to the ENTRIES.XLS spreadsheet and then the Zoom program to select "Share my Screen" and selects the window with the spreadsheet.
- 3. VIEWING AND SCORING THE IMAGES (Comments) Once this is done each judge should see a virtual copy of the ENTRIES.XLS spreadsheet. Then to display the first image the chairperson clicks on the first entry in the "Seq" column. This will display the first image using whatever image display software the chairperson uses for .jpg images. The judges then review and announce their scores. If the club is using the one score per image the chairperson enters the judges' scores in the TA, TB and TC columns. If the club is using the TCI three score per image per judge method the chairperson would get the individual scores and put them into the rest of the columns. If the club normally provides comments for all images they could enter any comments at this time. (see below if comments are not added at this time). Once that image is scored the chairperson would click on the Seq. column in the next row and continue the process until all the images are scored. It is probably a good idea to periodically save the spreadsheet to not lose precious judges' scores.
- 4. BREAKING TIES AND ASSIGNING AWARDS Once all the images have been scored the chairperson sorts the images by score using the macro in Ken's spreadsheet. The judges and the chairperson then use the method normally used by that club to determine the awards, using all the tools in Ken Johnson's spreadsheet. To view an individual image the chairperson just needs to click on the appropriate entry in the Seq. column of the spreadsheet.
- 5. COMMENTS When our club judges we add comments after all the scoring is completed as we only supply comments for entries that are below a predetermined score.

## **Judging Method Suggestions From Other Clubs:**

#### Saint Paul Camera Club "Low-Tech" Method

The Saint Paul Camera Club has a "Low-Tech" approach to holding digital judgings away from their normal meeting room.

- 1. Gene Schwope collects all of the images and loads them onto three Memory Sticks.
- On the day of the judging, he leaves three sticks in a box on the porch, along with three copies of the Excel score sheet.
- 2. During the late morning, the judges drive by and pick-up a stick and a copy of the score-sheet.
- 3. That night, and the next day, the judges score the images at their homes and write the scores on the spreadsheet.
- 4. On evening two, at appointed hours, the judges phone Gene with the scores in the judging order and Gene types them in his computer.
- 5. Gene totals the scores and sorts the file.
- 6. If there are ties, the tied images are emailed back to the judges with the needed instructions.

- 7. The judges make their selections and email Gene back with their results.
- 8. Gene enters the judges' wishes into Excel, makes the Mail Merge report-cards, and sends the Excel file to Ken Johnson.

They will try this method in April. It should work until they can get back to their regular judging room.

#### From Dan Ray, Black Hills Photography Club:

I want to say the following about Zoom (Method by John Larson):

- The photos do NOT have to be uploaded ANYWHERE, they exist just on the judges' computer system. They would share the screen the photos are on.
- The remote viewers would see the photos as seen on the judges' screen. (Note- limitations exist on the other viewer screens if they have a crappy monitor we can't help that with zoom). If the judges' system has two screens, the judge would share the screen the photos are on. (Ideal).
- · The judges all converse as on a conference call. Everyone can comment on the images. Comments made on the spreadsheet as per status quo.

The time limit (40 minutes) on the free Zoom version is the killer. Our judging sessions take up to 3.5 hours, once 4, so that would require a pro license, \$14.95 /mo.

From Craig Peterson, Minnesota Valley Photo Club: The last couple of times MVPC has conducted the judgings we have done this via SmugMug, Dropbox or OneDrive (doesn't matter what slide show platform). We have worked out any ties and issues via email or a few phone calls. We have found that having one lead person to make a final ruling is helpful.

#### From Pat Boudreau, North Metro Photo Club

I've sent the images to our judges via Dropbox and provided an Excel spreadsheet with the name of the images and room for their scores and comments. Once I get the scores back and compiled, we'll conference together using Jitsu, a free conferencing software that one of our members suggested. We'll use that to come up with the winners and placements based on the original scores. The test that we did with Jitsu seemed to work fine. We'll know more Sunday after we finish the scoring.

From Cyndy Thorn, La Crosse Area Camera Club: I upload my photos to Instaproofs (https://www.instaproofs.com/home/), which I am sure is similar to SmugMug... and I could do my clubs for judging to Instaproofs for sure / or learn SmugMug in a couple of hours. GREAT IDEA to upload and do at home! We can figure out from there how to proceed

My name is Dack Nehring. I am the President of North Metro Photo Club. During these crazy times it's more important than ever to keep our members engaged. So here are a few suggestions and tools that our clubs can make use of. And I welcome back any tips or suggestions.

Feel free to send this information on to all the clubs if you see fit (I didn't want to spam all the individual clubs).

- 1. Surveys I find it helpful to send one out every year so we can plan the future of our club and to give the members what they want (within reason). Attached is a version I built using the Google Docs Form module. Use some of the questions, add your own, or use the entire form customize as you see fit.
- 2. Web conferencing There is a great free, open-source service called Jitsi. The selling points of this service are:
  - 1. It's free (and there are no ads)
  - 2. No plug-ins are required, so that cuts down on tech support issues.
  - 3. No registration is necessary. Just name your room and send the link.
  - 4. You can share your screen (So doing something like Lightroom or Photoshop demos is very easy.)
  - 5. From what I have read it can handle up to 30-40 people before the signal degrades.
  - 6. The one requirement for this service is that it requires the use of the Chrome web browser.
  - 7. There are free plug-ins for iOS and Android devices

- 3. Recorded critiques. It's fairly easy to record critiques using Powerpoint and Keynote. Once the critiques are done the result is a video file that can be played on your website or uploaded to YouTube.
- 4. Keep your website updated. I struggle with this one because it's so easy to let days (weeks) go by without a blog post or new update. But by updating it, it gives our members something to engage with or react to.
- 5. Check in on your Facebook group. If you have a FB group, pepper in some questions to get your members talking. [Note to self do this]

Again, I welcome your suggestions and am more than willing to answer questions on these tools and services. So if you have never used Google docs before or recorded audio in Powerpoint or Keynote I'll try and help you, or any club that wants to give it a try. 
These are uncertain times, and photography can be a great distraction. And with our forced distancing, becoming a robust online community is more important than ever. Thank you for your time.

See the 2019-2020 N4C Handbook, Section F. Some revisions have been made to definitions for the contest categories. See the "Definitions and Rules from the Competition Categories" section. Also your club will be administering the awards when your club members have winners in digital contests. See Rule #26. Your club should have obtained a supply of awards to have available. An alternative 9 point judging method is described in addition to our customary T-C-I method. Familiarize yourself with these and other rules.

Encourage your members to explore the N4C website where they will find a lot of photography to study, and photography links with an unlimited number of tutorials and educational videos to learn from. http://n4c.us/

Entries must be received by 5:00 pm April 15, however make every effort to send them by the 13th to allow time for confirmation.

- Judging may begin on the 16th - make sure you receive confirmation that entries were received.

The cutoff time will be 5:00 pm on the 15th, giving the judging chair time to organize them for judging starting on the 16th. The point is....don't wait until the last minute. There have been problems with occasionally missing entries when they are not received until late in the night on the 15th.
