"The Sore Loser" "Memory Cards"

The direction of this months topic has taken a very different turn than I had anticipated even a day or so ago. A recently purchased memory card failed after I had taken about a 100 photos of dew covered flower buds with just perfect morning light. Those images couldn't be recovered and neither could the card. But it does make a good topic since I'm a little 'hot' right now.

I'd like to discuss three topics with memory cards. First, is capacity, second is the speed of the card in camera and when downloading, and third is how to minimize 'damage' when a card fails. The most common brands of memory cards are SanDisk, ATP, Lexar, Kingston, Transcend, Toshiba/Samsung, Hitachi, and Dane-Elec. The potential memory size varies from 1 Gb up to 32 Gb with my favorite size between 4 and 8Gb (see below for why!). Depending on the appetite of your digital camera a 4 GB card can hold between 100 to over 1000 images. For example, a Canon Power shot SX10 would be around 500 images because it saves images in


JPG format, while a 1D Mark III will take about 250 images in raw format, and a 5D Mark II will take about 140 images in raw format. The 5D Mark II chews up about 20 MB per image in raw format.

The advertising for new memory cards mentions words like 'extreme' or '300x' when referring both to the speed of acquiring images in the camera and secondly how long it takes to download images from a memory card to your computer. Take care when you read such advertising. To use Sandisk as an example—their naming progression started with Extreme I and is now at Extreme IV (which can process 40 MB/s). A four year old camera won't take advantage of the newest card while a Canon 50D or 5D Mark II for example will process images fast enough for you to tell a difference. Keeping up with the cat on the left can make use of a fast camera and a fast memory

card while the flower above might be more understanding if you can't snap away with the same speed. Download speed is the most critical difference—the newest cards have an advantage if you can use at least a USB2 connection—and even better if your computer can use Firewire 800—you won't need to have a cup of coffee or read a book while waiting!

The two most common formats are SD or SDHC and the CF or compact flash. Cards regardless of type will fail. I've found out the hard way. The SDHC are more likely to fail from handling issues while the CF cards take handling well, but seem to be more likely to fail when pushing maximum capacity and speed. Why do I choose cards between 4 and 8 GB? **If these fail—I haven't lost a full day's shooting.** Many cards also come with software to recover images—Sandisk comes with "Rescue Pro" that will often recover images from an otherwise 'dead' card. I keep looking for that perfect memory card—I've never had one that's too fast or that can keep up with the "cat" when it's moving!
